## GENERAL CONDITIONS :-

### 1. Age Limit:-

- (i) The age shall not be more than 35 years for the post of Assistant Professor. Upper age limit shall be determined as on the last date for submission of application as mentioned in the Advertisement. Relaxation in upper age limit to ST/SC/OBC and women and Divyang (Differently abled) candidates will be provided as per C.G. Govt. Rules.
  - (ii) For Assistant Professor or equivalent post, there will be no upper age limit bar for the regular employees/officers of the Chhattisgarh Kamdhenu Vishwavidyalaya, Durg.
  - (iii) Permanent/temporary/contractual employees of government of Chhattisgarh or any undertaking of government of Chhattisgarh will be entitled for age relaxation as per government rules.
  - (iv) As per the order of Govt. of Chhattisgarh the upper age limit for the bonafide resident of Chhattisgarh will be 40 years. However, the age should not be above 45 years including all relaxation as per Govt. rules.
2. Reservation for ST/SC/OBC candidates shall be available as per the Chhattisgarh Lok Seva (Anusuchit Jatiyon, Anusuchit Jan Jatiyon Aur Anya Pishhade Vargon Ke Liye Arakshn) Sansodhan Niyam 2011, 2012. The applicant under Schedule Caste, Schedule Tribe, and Other Backward Class category, should be bonafide resident of Chhattisgarh and should be a member of schedule caste/schedule tribe/other backward class which have been included in the list of respective category as notified from time-to-time by state Govt. of Chhattisgarh.
  3. 30% reservation will be available for female applicant in each category as per C.G. Govt. rules.
  4. 6% reservation will be available for Physically Handicapped (disabled) applicants as per C.G. Govt. rules.
  5. The selected candidates shall be governed by the Vishwavidyalaya rules and service conditions.
  6. Applicants must have attained the requisite qualifications and experience on or before the last date for submission of application as mentioned in the Advertisement.
  7. Applications not accompanied with copies of certificates, degrees, mark sheets/transcripts in support of academic qualifications and experience shall be rejected.

10. The applicants shall be required to present themselves before the selection committee, if called for interview, at their own expenses. ST/SC applicants will be allowed traveling allowance as per Vishwavidyalaya/C.G. Govt. rules.
  11. Applicants from reserved category (ST/SC/OBC) who have applied for respective category are required to enclose caste certificate issued by competent authority failing which their application shall be considered under unreserved category. Applicants appointed on reserved posts will have to submit an undertaking in prescribed format regarding their caste certificate. In case their certificate found illegal or fake, their appointment will be terminated and they will be subjected to punishment as per law.
  12. Higher initial start may be granted to deserving applicants as per provision CGKV rules.
  13. Appointment to the post shall be temporary and the selected candidate will be kept on probation for two years and their service may be terminated if probation is not cleared.
  14. Selected candidates on the post of Assistant Professor & equivalent will have to submit a judicial agreement bond to serve the university for **three years** as prescribed by rules of the Vishwavidyalaya.
